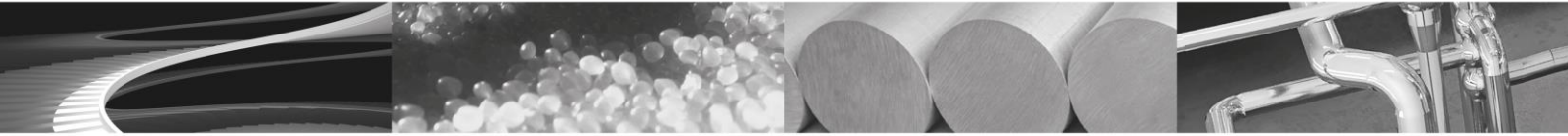


Introduction to the Course

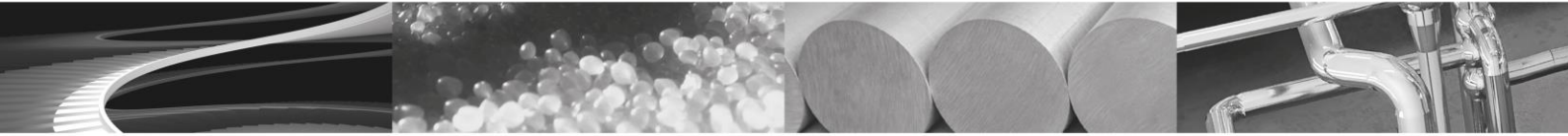
